




Authorised complementary and herbal medicinal products, without notification procedure (2019 to 2023)



In the reporting year 2023, the number of authorised homeopathic medicinal products (587), anthroposophic medicinal products (342) and herbal medicinal products (395) decreased again. The mean reduction in authorised medicinal products, excluding Asian medicinal products (6) and medicinal products used in other schools of complementary medicine (5), has remained roughly constant over the last three years.


Classification of authorised herbal medicinal products in 2023

The authorised herbal medicinal products are subdivided into the following groups of the Anatomical Therapeutic Chemical classification system (ATC) and are categorised below based on the dispensing categories.


Most authorised herbal medicinal products are assigned to the ATC groups of Alimentary tract and metabolism (106), Respiratory system (90), Nervous system (74) and Genito-urinary system (60). In addition to the prescription-only drugs used in herbal medicine, the Swiss public can medicate themselves with a wide range of safe, high-quality herbal medicines, which are available without a prescription in dispensing category D (after expert advice) or in dispensing category E (over-the-counter).

Authorised herbal medicinal products by dispensing category







Classification of authorised complementary medicinal products with indication in 2023

The authorised complementary medicinal products with indication are subdivided into the following groups of the Index Therapeuticus (IT) and are categorised below based on the dispensing categories.

Authorised complementary medicinal products by IT Group



Authorised complementary medicinal products with indication by dispensing category



Complementary medicinal products with indication are dispensed on a prescription-only basis in dispensing categories A and B, and without a prescription in dispensing category D after expert advice.



New authorisations of complementary and herbal medicinal products in 2023

Complementary and herbal medicinal products can be authorised using a simplified authorisation procedure in accordance with Art. 14 para. 1 let. b of the Therapeutic Products Act (TPA, SR 812.21) or Art. 14 para. 1 let. cbis TPA. A total of 16 medicinal products were authorised in procedures of this type.

In 2023, one application submitted according to the procedure described in Art. 13 TPA (Medicinal products and procedures authorised in foreign countries) was approved. No procedures according to Art. 14 para. 1 let. abis-quater TPA were concluded in the year under review.



Authorised complementary medicinal products without indication under the notification procedure (2019 to 2023)

The number of authorised homeopathic or anthroposophic medicinal products, medicinal products for gemmotherapy and Asian medicinal products without indication under the notification procedure according to Chapter 6 of the Complementary and Phytotherapeutic Products Ordinance (KPTPO, SR 812.212.24) increased slightly in 2023 (10,990 medicinal products).



Authorisation was withdrawn in 2023 for 20 suspended homeopathic medicinal products without indication authorised under the notification procedure.

In 2023, 214 medicinal products used in Chinese medicine (TCM) without indication were converted from transitional authorisation (Art. 95 para. 3 HMG) to an authorisation under the notification procedure. The conversion of other medicinal products used in Chinese medicine is still outstanding.



A.109 regulatory changes (2019 to 2023)

Implementation of the new requirements in accordance with the revised TPLRO

Full declaration became mandatory for all medicinal products when the revised therapeutic products legislation came into force on 1 January 2019. These adaptations to the requirements are requested with an A.109 regulatory application. Single and multiple applications are considered below.

In 2023, 87 A.109 applications were concluded.



Since the revised therapeutics products legislation came into force on 1 January 2019 and a consequent increase in A.109 applications received, the annual number of newly submitted A.109 applications continues to decline. The number of A.109 applications concluded in 2023 fell slightly compared to the previous year, in contrast with all other applications (new authorisations, variation applications, authorisation extensions and safety-related applications).



Other activities

Updating of the list for naturopaths

The list of medicinal products designated by Swissmedic to be dispensed by specialists in complementary medicine with a Swiss diploma was supplemented in 2023 by the list of 234 Chinese medicinal products without indication authorised under the notification procedure.

IDMP

The term Identification of Medicinal Products (IDMP) covers a set of standards that make it possible to uniquely identify and describe medicinal products with consistent documentation and terminologies (for further information see the Swissmedic website, keyword IDMP).

Swissmedic will use the IDMP standards for the exchange of medicinal product data. The CHM Division is involved in the preliminary work for applying the IDMP standards to herbal and complementary medicines.

Transformation of Swissmedic platforms (TSP)

Swissmedic is working on the next step in digitalisation and over the next few years will build a digital corporate solution for core processes relating to licensing, authorisation and market surveillance (for further information see the Swissmedic website, keyword TSP).

Since 2023, the CHM Division has been involved with its own project for digitalising the notification procedure.
