SUMMARY OF RISK MANAGEMENT PLAN FOR SYNJARDY (EMPAGLIFLOZIN+METFORMIN)

This is a summary of the risk management plan (RMP) for Synjardy. The RMP details important risks of Synjardy and how more information will be obtained about Synjardy's risks and uncertainties (missing information).

Synjardy's Summary of Product Characteristics (SmPC) and its package leaflet give essential information to healthcare professionals and patients on how Synjardy should be used.

This summary of the RMP for Synjardy should be read in the context of all this information including the assessment report of the evaluation and its plain-language summary, all which is part of the European Public Assessment Report (EPAR).

Important new concerns or changes to the current ones will be included in updates of Synjardy's RMP.

I. THE MEDICINE AND WHAT IT IS USED FOR

Synjardy is authorised the treatment of adults with insufficiently controlled type 2 diabetes mellitus (see SmPC for the full indication). It contains empagliflozin and metformin as the active substances and it is given by oral administration.

Further information about the evaluation of Synjardy's benefits can be found in Synjardy's EPAR, including in its plain-language summary, available on the EMA website, under the medicine's webpage.

II. RISKS ASSOCIATED WITH THE MEDICINE AND ACTIVITIES TO MINIMISE OR FURTHER CHARACTERISE THE RISKS

Important risks of Synjardy, together with measures to minimise such risks and the proposed studies for learning more about Synjardy's risks, are outlined below.

Measures to minimise the risks identified for medicinal products can be:

- Specific information, such as warnings, precautions, and advice on correct use, in the package leaflet and SmPC addressed to patients and healthcare professionals;
- Important advice on the medicine's packaging;
- The authorised pack size the amount of medicine in a pack is chosen so to ensure that the medicine is used correctly;
- The medicine's legal status the way a medicine is supplied to the patient (e.g. with or without prescription) can help to minimise its risks.

Together, these measures constitute routine risk minimisation measures.

In addition to these measures, information about adverse reactions is collected continuously and regularly analysed, including PSUR assessment so that immediate action can be taken as necessary. These measures constitute routine pharmacovigilance activities.

If important information that may affect the safe use of Synjardy is not yet available, it is listed under 'missing information' below.

II.A List of important risks and missing information

Important risks of Synjardy are risks that need special risk management activities to further investigate or minimise the risk, so that the medicinal product can be safely taken. Important risks can be regarded as identified or potential. Identified risks are concerns for which there is sufficient proof of a link with the use of Synjardy. Potential risks are concerns for which an association with the use of this medicine is possible based on available data, but this association has not been established yet and needs further evaluation. Missing information refers to information on the safety of the medicinal product that is currently missing and needs to be collected (e.g. on the long-term use of the medicine).
